- Edges: 2 sm of all sides

– Text formatting: font size: Times New Roman, 10 pt, single spacing, paragraph indent – 0.8 sm

- Formulae, symbols, variables that occur in the text must be typed as Microsoft Equation objects

- Figures and tables should be clear and compact (8-9 pt, single spacing).

NOT ALLOWED: hyphenation in words (including automatic one); scanned formulae, figures and tables, ungrouped figures; footers set.

The editorial board reserves the right to select scientific materials for publication in the monograph.

The article should be a complete material of scientific content, including the results of the author's original research with an introduction, main body, conclusion and references.
